Purpose:

Request for Quotation (RFQ) for 2Mbps Internet Connectivity with Public IPs

Specifications/Descriptions:

WACREN needs an internet service provider (ISP) to supply a reliable **2Mbps dedicated internet connection** with **IP addresses** to support the remote management of our **Out-of-Band (OOB) devices** located in various Points of Presence (POPs) in **West Africa**. The service should be provisioned through an Indefeasible Right of Use (IRU) agreement with an initial **five-year term** to ensure long-term availability and stability of connectivity.

Scope of Services:

- **Internet Connectivity:**
 - **Speed:** 2Mbps (minimum sustained bandwidth).
 - **Type:** Dedicated or leased line (no shared bandwidth).
 - **Connection Interface:** Ethernet (GigE or higher).

- **IP Address Allocation:**
 - **IPs:** /29 IPv4 and /56 IPv6
 - **Configuration:** ISP will provide documentation on proper assignment and usage of the allocated public IPs.

- **Service Level Agreement (SLA):**
 - **Uptime Guarantee:** **99.9% uptime** minimum guarantee.
 - **Latency:** Provide typical latency metrics for connectivity to the nearest international POP.
 - **Support:**
 - **Critical issues:** Response time within **1 hour**, resolution within **4 hours**.
 - **Minor issues:** Response time within **4 hours**, resolution within **24 hours**.

- **Security:**
 - **Network Security:** Ensure the public IP addresses are securely routed and provide recommendations for network hardening, if necessary.



- **Installation:**
 - **Connection Setup:** The ISP is responsible for end-to-end provisioning the 2Mbps internet connection.
 - **IP Configuration:** The ISP must provide documentation or remote support for proper setup.

- **Monitoring and Reporting:**
 - **Real-time connection monitoring** (ISP should specify the level of visibility provided)
 - **Service Reports:** Monthly performance and availability reports.
